### Registration in exceptional cases

In exceptional cases, please e-mail our exam team (aip-pl-klausur@tu-braunschweig.de) by e-mail with the subject "Advanced exam" by 30.06.2024 with the following information:

- Name and matriculation number
- > Study program (e.g., industrial engineering field mechanical engineering, business informatics, ...)
- Degree (bachelor or master)
- Type of exam (e.g., orientation A, single exams, ...)
- ➤ Lecture(s) (e.g., Sustainability in production and logistics, ...)
- Grade notification (certificate to pick up at the institute or direct transmission to the examination office)

This includes all Bachelor's and Master's students who cannot register for an exam via the TUconnect portal or need an oral exam appointment. Oral examinations are only conducted in exceptional cases with appropriate proof.

Your registration in exceptional cases can only be considered if it is <u>submitted by 30.06.2024</u> at the latest and <u>contains all the required information</u>.
